HSE policy implementation

- Assist in compliance reviews, general risk assessments and other safety assessments to support HSE managements.
- Set up, follow up and ensure the compliance with the legal requirements within the plant
- Support and deployed Safety & Environmental Software (I-CARE / Cority)

Risk management

- Identify the risks and correct potential hazards by inspecting facilities, machinery, safety equipment, and work process.
- Stop the machines or technical device in case of danger to life or health
- Organize job safety analysis and find out the solution to get rid of the risks with operational teams.
- Investigate industrial accidents, injuries, or occupational diseases to determine their causes and find out preventive actions.
- Perform accident/incident investigation, report, record and analysis.

HSE operation

- Plant patrol on a regular basis to establish HSE presence and provide support.
- Evaluate, advise action, improvement of key indicators such as, the quality of emergency drill, safety meeting, safety induction and on the job safety training
- HSE report to government on monthly/yearly basis.
- Monitor & audit working area, ensure the compliance of safety standard.

Training & communication

- Plan, organize, evaluate the program / activities to build employee awareness on HSE
- Carries out any in-house HSE trainings / HSE audits on sub-contractors.

- Communicate safety knowledge to employees, create HSE campaigns, and bulletin board for communication
- Set up HSE committee and develop them to be active team.
- Manage communication / campaign to build up HSE awareness and create HSE mindset atmosphere.
